## Dear Senator Daines,

I am honored to write this letter in full and complete support for your selection of Kurt Alme to fill the pending position of U.S. Attorney for the District of Montana. I worked in the U.S. Court system for the District of Montana in Billings, Montana for 25 years as a U.S. Probation Officer and as a Probation Officer Supervisor for the last 11 of those years.
