Dear Senator Daines,

I write in support of Kurt Alme for the position of United States Attorney for the District of Montana.

I started the private practice of law in Hardin, January of 1972 (12 years), elected Big Horn County Attorney for three terms, 1974, 1978 and 1982. I was hired as an Assistant United States Attorney in May of 1984 to head the OCDETF (Organized Crime Drug Enforcement Task Force) in the US Attorney's Office (1984-2012).
