Dear Senator Daines:

I wrote you with my whole hearted endorsement of Kurt Alme for the U.S. Attorney for the District of Montana.

I worked at the Montana State Auditor's Office from 1996 until 2008 (with a brief detour to the Montana Attorney General's Office). I worked as both an attorney and chief investigator while at the Montana State Auditor's Office.

When we had large white collar criminal cases, we would turn to the Montana U.S. Attorney's Office because they were better resourced to handle complex cases for prosecution. One such case involved Myron Felt, who was collecting hail insurance premiums and failing to remit that premium to insurance companies. I was heavily involved, as I supervised the State Auditor investigators at that time. It was a complex case in that it was document intensive and involved a lot of transactions in the arcane world of hail insurance. Kurt Alme was the federal prosecutor of this case.

As part of the State Auditor investigation team, I would meet or have phone calls with Mr. Alme on this case. Mr. Alme was wonderful to work with and he is adept at handling these intricate cases. He concisely cut through the complexity resulting in Mr. Felt being sentenced to 40 months for wire fraud. Mr. Alme also ensured that the damaged parties, in this case, various insurance companies, received restitution, of over \$500,000.

In the bigger picture, when I worked at the State Auditor's Office, the elected official was John Morrison, a Democrat. Mr. Alme never let partisan politics become involved with the investigating and prosecuting of criminal acts. His door was always open when we in the State Auditor's Office would bring cases to the Montana U.S. Attorney's Office for possible federal prosecution.
