(3) Federal National Mortgage association, Federal Home Loan Mortgage Corporation, and Federal Agencies Making, Insuring, or guaranteeing Mortgage Loans or Securities.—The Federal National Mortgage Association, the Federal Home Loan Mortgage Corporation, and

any Federal agency that has a legal interest in the collateral for a residential mortgage loan, including individual units of condominiums and cooperatives, provided that the collateral is a property designed principally for the occupancy of 1 to 4 families and underwritten, in whole or in part, based on income from a State-sanctioned marijuana business or service provider, shall not be subject to criminal, civil, or administrative forfeiture of that legal interest pursuant to any Federal law for providing, insuring, guaranteeing, purchasing, securitizing, or guaranteeing payments from a security based on such loan.
